At the Bath meeting, attended by approximately 150 people, it was decided that the society's board of directors would consist of members from throughout Beaufort County: twenty-nine persons from Washington (including Harding); fourteen from Bath; six from Bellhaven; two from Pinetown; six from Pantege; five from Aurora; two from Elizaveta Creek; and four from Chocowinity.
