

May 31, 1809 - Beaufort Co., DB8-40 - This Indenture, Tripartite, made this 31st day of May 1809 Between Sally Rose and John Anderson of the Town of Washington, County of Beaufort, and State of North Carolina, of the one part, and William Orr of the Town, County, and State aforesaid of the other part. Witnesseth that whereas the said Sally Rose being about to intermarry with the said Jno. Anderson by and between whom, it hath been stipulated and previously agreed, that all such Estate as the said Sally now holds in her own right, Should be secured previous to her Marring, for her future as well as present disposal and enjoyment, to which intent and purpose the said Sally hath as well, for and in consideration of the sum of Five Shillings to her in hand paid, by the said William Orr, at, and before the Sealing and delivery of these presents, the Receipt of which is hereby acknowledged and as for and in consideration of, reliance on and confidence in the said William Orr, have conveyed, confirmed, assigned and set over, and by these presents doth convey, confirm, assign and set over unto the said Wm. Orr, his Executors and Administrators in Especial trust and confidence, to and for, the uses and intents, and purposes hereinafter mentioned: The Five following Negroes Slaves (to wit) Hannah, Sam, Hull, Andrew, and Hannah a Child, for and to the following uses, intents and purposes (Viz) to and for the joint use of the said Jno. Anderson and Sally Rose, for and to permit the said John and Sally, to have, use, possess and enjoy and take the Labour and profits thereof, and to their joint use during their joint lives, and to the use of all the Children of the said Sally, share and share alike. And in case the said Sally shall die without leaving of any children living, then to the sole use and benefit of the said John Anderson, should he be living. And if he should not be then to such person or persons, as she may give or bequeath them to. And it is hereby stipulated and understood by and between the parties to these presents, that the said William Orr, his Executors, Administrators, or Heirs shall convey the same agreeable to the Gift or bequest of the said Sally immediately after the said Gift or bequest. during their joint Living, and to the use of said Sally, during her whole state
and life, and then, to the use of all the Children of the said Sally, Share
and Share alike. And in Case the said Sally shall die without leave-
ing of any Children living, then to the sole use and benefit of the said
John Anderson should he, be living. And if he should not be living,

then to such person or persons, as she may give or bequeath them to
