Rodman, received a letter from a lawyer in Liberia representing the heirs of Hull Anderson. This correspondence is not available. It is assumed that since Hull Anderson had left Beaufort Co. his property was sold for non payment of taxes.

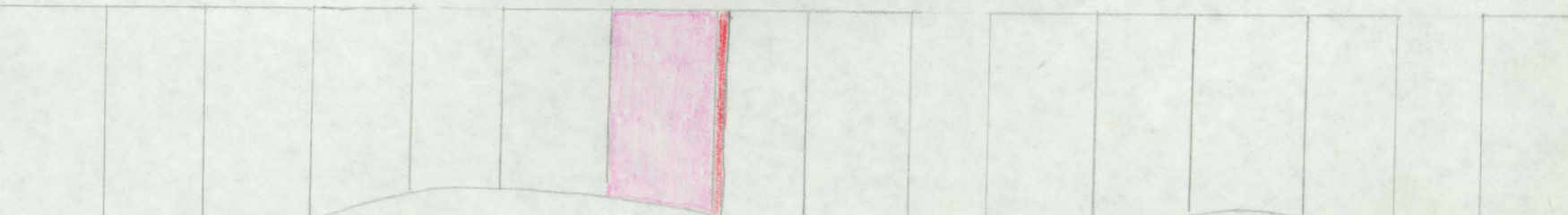
